## **1** Executive Summary

This document presents the overall structure of the EBSI-VECTOR project website. This website will be accessible from the domain <u>https://www.ebsi-vector.eu/</u> where a landing page is available now until final release of the project website (expected date at the end of October 2023).

This website will be the main tool for disseminating project outcomes outside the consortium and will enable to fulfill the WP7 objectives together with WP6 outcomes as well as public project deliverables. ## 2 Introduction

The present document constitutes Deliverable D7.2. Project website in the framework of the project "EBSI-VECTOR - EBSI enabled VErifiable Credentials & Trusted Organisations Registries" (Project Acronym: EBSI-VECTOR; Contract No.: 101102512). This document is the result of the activities performed within the Work Package 7 (WP7): "Dissemination, Communication and visibility", and more specifically of Task 7.2 Dissemination and awareness management led by IZERTIS and in collaboration with the rest of the consortium partners.

EBSI-VECTOR intends to improve the capabilities of social security, educational credentials and eSSIF use cases, extending the paradigm of self-sovereignty, and decentralized verifiable credentials and decentralized trusted registries for each use case related with real end user services for European citizens via the support of the European Blockchain Service Infrastructure (EBSI) and implement this in different countries and cross-border interactions. In this sense, the aim of the dissemination, communication and visibility (WP7) is composed of the following aspects (\* mainly tackled by the website):

- Definition and implementation of the best communication and dissemination plan for each target audience. \*
- Definition and implementation of the exploitation plan according in coordination with IP management and technological surveillance actions.
- Identification of synergies with other relevant projects and initiatives related to EBSI. \*
- Stakeholders' engagement and collection of their recommendations and guidelines for future initiatives. \*
- Increase of awareness and knowledge in relation to EBSI and existing EBSI related initiatives or actions. \*

Moreover, WP7 is performed in close collaboration with WP6 (Ecosystem building, policy support and sustainability). The project website will be the main tool for achieving such aims, combining needs and requirements from all the project work packages. According to Gran Agreement (page 26) provisions, the website will be updated during the project and will be active for at least a year after the project. All partners from the consortium will provide content to update the website. A methodology for a regular collection of content will be provided as established in D7.1 and D6.2 together with updated approaches.




Figure 3. Overview of EBSI-VECTOR website – "Work packages" section



## 2.1.6 News and events






Figure 11. Overview of EBSI-VECTOR website – "Contact us" section

Figure 12. Overview of EBSI-VECTOR website – "Search" functionality for "Izertis"


## **2.2** Compliance with relevant regulation
