Who we are

The **EBSI-VECTOR** (EBSI-enabled Verifiable Credentials and Trusted Organisations Registries) project is a **two-year-long initiative** that harnesses the self-sovereign identity paradigm to transform digital interactions within the educational and social security sectors. With a **consortium of 54 Organisations**, Public Bodies, SMEs and Large private entities, from **20 different European countries**, the project aims to streamline European citizens' digital experiences, simplifying complex verification processes. Through decentralisation and collaboration, our project empowers citizens and organisations, offering a secure, privacy-friendly, and efficient experience. It will be tested in **3 use cases**: *Education, Social security Business registries*.

We **won the INATBA Awards 2024** under the "Public Sector Innovation category". INATBA facilitates positive change in the blockchain ecosystem across diverse fields including Education.

We are also one of the first pool of selected projects by the **European Blockchain Sandbox**, a pan-European framework for regulatory dialogues for innovative use cases promoted by the European Commission.

We were speakers in two sessions in the **EBSI Ecosystem day!** During this event over 25 projects shared their common vision as pioneers in the use of EBSI. EBSI-VECTOR was there together with 350 organisations from over 30 countries.

Moreover, we organised an **EBSI-VECTOR Conference** in France among the European Education ecosystem to showcase the potential of blockchain through EBSI services and EBSI-VECTOR use case in this domain.

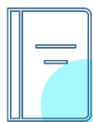
